SURPLUS

Billy provided the Income Statement for 2023-2024 fiscal year, a year to date for the 2024-2025 fiscal year, and a year-to-date balance sheet. Billy has also provided a break down of the financial information (*document can be viewed in the 2024-2025 November BoD Meeting Folder on the Shared Drive*). Billy gave a break down of the finances and to date the BLBRA has spent 37% of the budget and is on track to spend the full amount by the end of the fiscal year. As money comes into the BLBRA Zoe will record it into the cash can account. Billy said the next balance sheet he completes he will have more notes. Motion to approve the financial update made by Terri Shobbrook and seconded by Parker Donham – motion passed.

Allison asked the BoDs in attendance if any of them would like to take on the role of the treasurer and described the role. Allison also explained that there is a Finance Committee which will also

support the treasurer. Allison will reach out to the BoD's not in attendance if they are interested in the treasurer role.

6. Mi'kmaw Climate Change project update: Jay Denny & Anik Martin

Jay and Anik, both with UINR, are working with Mi'kmaw communities gathering information about climate change and concerns within the community. They plan on having outreach presentations which in each community about climate change adaptation and impacts. They are also working on climate change and monitoring.

Teaching kits – All the TD funds were not spent so more items were purchased to use up the rest of the funds - the final report was submitted
Water testing kits – the committee is looking for different people around the Bras d'Or interested in gathering the data in their location and reporting it. Each kit cost about \$450 so they would like to find a dedicated amount of people to use the kits.

Proposal – Kirsty put a proposal into the East Coast Credit Union, the proposal is seeking a part time worker for the CEAL Committee to have it going all year round.

ii) Trails – Ron Newcombe

There were 5 walk the trail series this past summer. The first and last walk were successful (Spring and Fall walk), 2 of the walks were cancelled and 1 was not attended very well. The Trails Committee will continue to connect with trail groups including talks with Trail Nova Scotia. Teresa McNeil (with Johnstown Trail group) asked if the BLBRA will issue receipts on their behalf, so they can apply for funding. Kathleen suggested a proper MOU be signed with the Johnstown group as a kind of partnership if the BLBRA agrees.

iii) Communication Committee – Pierre LaRochelle

Pierre attended 2 sessions one being a summit in Membertou hosted by Destination Cape Breton. A booth was set up at Membertou and Pierre made connections with the World Tourism Institute.

Kathleen informs the group that Destination Cape Breton is doing a stakeholder engagement study on sustainable tourism, and they are looking for people to interview – Pierre and Terri both submitted their names.

Report for the signs is not fully completed – holding over for the next BoD meeting in January 2025.

v) Project Manager Hiring Committee – Kathleen Aikens

The Hiring committee consisted of Kathleen, Terri, Rod and Zoe. The posting went out in October and closed on November 1st with a total of 26 applications. There was a total of 4 interviewees, and each were assessed through a grading matrix. There was a top candidate, and the hiring committee is on the next steps of reference check.

There were some discussions about taxes and other costs that would be associated with the acquisition of the land. b) **Grover Blaire Estate donation** – Teresa submitted a proposal about a data hub but was not accepted by the estate managers. There is a possible \$5,000 available and Teresa will look into it again.
